# Nurture Lakeland/Love Your Lakes

The Chair went onto introduce Helen Moriarty of "Love Your Lakes" who gave a short presentation on the work being undertaken by that organisation. Helen pointed out that Love Your Lakes, which is part of Nurture Lakeland, works in partnership with Windermere Reflections to improve water quality in Lake Windermere and the surrounding catchment lakes. "We're helping local businesses, residents and visitors to take simple steps to reduce the use of phosphate. By reducing the amount of damaging phosphates entering the lakes we can all do our bit to protect the future of one of Lakeland's most beautiful destinations. You can do your bit to reduce the amount of phosphates getting into the lakes by simply choosing phosphate free laundry and dishwashing

products. Always check the labels of your laundry and dishwashing products to ensure they are phosphate free."

Helen then went on to give a brief resume of the work 'Nurture Lakeland.' Nurture Lakeland is a registered charity with seven full time members of staff based at our office in the lively village of Staveley in the heart of the Lake District and Cumbria. They currently have over 275 business members representing more than 1200 tourism businesses and holiday cottage owners across Cumbria, all of whom are committed to protecting this area for now and for the future. Their business members are very generous in their support of conservation in Cumbria. Nurture Lakeland is closely involved in developing policy and strategic planning to enable us to protect and conserve the very special landscapes, culture and heritage of the Lake District National Park and Cumbria.
