The Secretary reported that he had attended a meeting of the Windermere Lake User Forum as an interested member of the public. He went onto report that he had received an email from United Utilities which was at odds as to what had been said at the meeting with regards to the Windermere & Bowness Civic Society's application for 'Village Green' status of the Glebe and the work to be carried out on the Sewage Tank.

# AOB:

- The Secretary asked those assembled to agree to the purchase of a wreath on behalf of the Chamber of Trade to be laid at the War Memorial on Sunday 8<sup>th</sup> November. The amount would be £30 to include a donation to the "Poppy Appeal." This was agreed to and the Secretary offered to attend the service on behalf of the Chamber.
- The Secretary handed out to the meeting a number of 'mockups' of suggested 'Certificates of Membership' for discussion. It was decided that while the certificates had great visual impact they were likely to be put to one side and not displayed as intended. It was suggested that the Secretary investigate the possibility of the Chamber obtaining a quote for 'window stickers.'
- The Secretary, in his capacity as Webmaster, reported that for the month of September there had been 54,600 world wide 'hits' on the Chambers website. He pointed out that a number of them were coming from some very unusual sources; Ghana, Ivory Coast, Uganda, China, Vietnam, Yukon Territory a as well as the usual European countries. He also reported that the most used Search Engine was "Google" and the most used *Entry Page* was the home page. The most popular day for visiting the website was a Tuesday!
- David Howarth gave a report on behalf of the Windermere & Bowness Winter Lights Group and stated that 13 sections of lights were to be repaired and 3 new sections were to be installed in Bowness.
