The Secretary reported that he had received an email from PCSO Jonny Gios who had resigned and working his notice with Cumbria Police.

From September he will be working two days a week for 'Cinnamon Network' that works with Police Forces/Councils and predominantly churches to set up social action projects. They had received monies from Mr McCall to set up Street Angels in Barrow and a number of other initiatives. He will also be starting a new project from my church I attend in Kendal called Neighbourhood Chaplains – this is very much like Street Angels (which I helped set up in Barrow) but during the day and in community walking the street in pairs. I'm sure it will be a valuable asset to Kendal.

He pointed out that there are no plans to replace him at the moment – so PCSO Sarah Blacow will probably cover in the meantime until that happens possibly next year.

## Report from the Windermere Town Council Representative.

Cllr. John Saunders (Mayor of Windermere) reported;

- a. That there were 16 spare CTV 'slots' available and that the town council, after assessing the need had applied for 3 of them.
- b. The town council have been working with Cumbria County Council on a number of projects ie lamp posts, grass verges etc. There are external restrictions on the amount of work that can be done.
