### Minutes

# **United Utilities**

The Secretary reported that he had had a meeting this afternoon with 2 officers from United Utilities (UU) working on the A592 Wastewater Project. The officers reported:

- UU will fully restore the 2 way traffic the full length of the A592 during the forthcoming half term.
- UU will be finishing the current phase of work no later than the 31<sup>st</sup> March 2017.
- All signaging will be removed and not re-instated until the end of October 2017.
- UU will look into not putting back the 'Diversion' signs that are currently in place throughout Windermere and Bowness.
- The manual electronic signing at Hammer Bank, Rayrigg Road, will be re-worded more appropriately. The sign carries 3 screens which revolve to show a complete message. However if only one screen is read it can lead to the misapprehension that Windermere & Bowness are closed. Assurances were given that this was in the process of being changed.



- UU were asked to look at the other manual signs to see if there was not a similar problem, if so to amend. Theses signs are at the
  - o Plumgarth Roundabout, and
  - the Newby Bridge Roundabout.

# Correspondence

The Secretary reported that he had received an email from PCSO Sarah Blacow regarding the fraudulent Scottish fivers. She pointed out that 'they can feel waxy but have the same serial number. The problem is that's just one batch others can have no water mark or no strip so it is not always easy to tell. The best way is if in doubt don't except.
