Report on the Sculpture Trail.

The Secretary reported that he had arranged a site visit with Neil Henderson (LDNPA Planning Officer) for a site visit on the 15th May 2018. Various members of the Sculpture Trail Sub-committee indicated they would like to attend. This was **AGREED** to by those present.

- Windermere Diessen Town Twinning Association update by Tony Blaney saying that he and Liz would be visiting Diessen in their own right as part of the 20th Anniversary Celebrations of 'twinning' between the two communities.
- Windermere in Bloom / Cumbria in Bloom Nothing to report
- Lakes Line Community Rail Partnership The Secretary reported that he had been asked by a number of people regarding a leaflet that was circulating the village regarding effluence being deposited on the rail tracks at various stations. He stated he had made contact with Dick Smith (LLCRP) who reported:

"The leaflet comes, I think, from Dr Jonathan Ward, who appeared in the Gazette a few weeks ago about this campaign. He's right that it's unsanitary, and a step backward. However, there is a programme for fitting retention tank toilets as part of the general refurbishment Northern's older trains are having, so it is a reducing problem. I suspect that the most practical solution is the hosepipe at Oxenholme station, even though it's less than ideal."

The Secretary had also made reference to the number of cancellations Northern had made on the Lakes Line, Dick Smith replied

"Regarding the cancellations, we logged over 150 in April. What can we do? We have written (LLRUG and/or LLCRP) to David Brown, MD of Northern also the DfT and Transport for the North, and all of them have had facts and figures to show what is happening here, which is often worse than Northern seems to admit. Jim Jackson from the LEP has met David Brown, Tim Farron has contacted DfT, all to no avail so far. All I can think is that the more pressure, the better. If the Chamber wanted to write to David Brown and or the DfT, it might help. The Rail Minister is Jo Johnson."
